It processes the inputs provided such as personal information, images/photos and technical details in a user driven environment. WSL is not responsible for any damages or technical implications arising out of commercial or non-commercial use of this app.

Information we collect, use and share

Personal Information

Personal Information is information that identifies you or another person, which may be transmitted or received when using the software. WSL does not collect any personal information using Windowmaker Measure app.

You may voluntarily give access to personal information when you:

- > Register yourself on our web page
- > Use our customer support
- > Participate in an online survey or in a forum/blog
- > Express your interest to receive newsletters & email communications

When you give access to your personal information, WSL may collect a variety of information, including your name, address, phone number or email address. WSL may use your personal information to:
